C. WIAA (Tim)

- a. 16 Team Basketball Tournament – The State Basketball Tournament Committee (school board members, superintendents, principals, athletic directors, coaches and WIAA Executive Board and staff members) presented to the WIAA Executive Board their findings from surveying state superintendents and school leaders. The committee's survey asked school administrators about additional revenue options to support the return of the 16-team basketball tournament. The Board agreed to continue the conversation and created a sub-committee to develop discussion points which will be placed on the March Board agenda.
- b. Football finals will be in Tacoma Dome for the next 3 years through the fall of 2018. West side semi-finals will be moved to regional sites.
- c. Allocation process for new 4 year classification cycle. 3 options proposed:
 - 1. 2 year (same as current) recommended by WIAA staff
 - 2. 4 year (to match classification)
 - 3. Rollover method. (travel sports 2 years, tournament sports rolled over, other)
